Saggiani Rule:

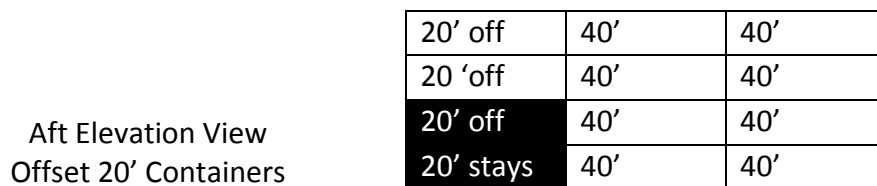
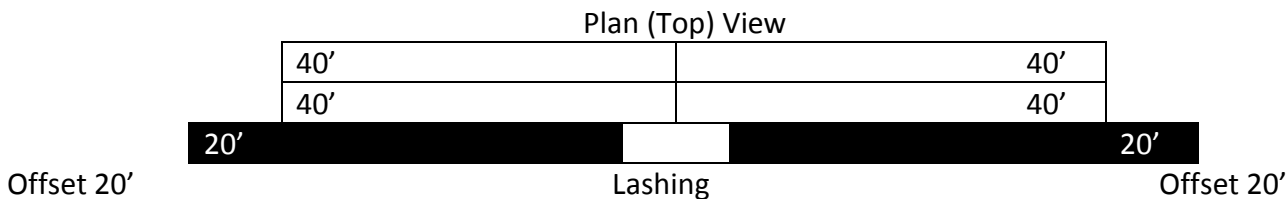
In the event that on deck 20' containers are offset of the abreast container stack, the following protocol shall be used:

DUTIES OF EMPLOYER/FOREMEN/SUPERCARGO

- A. Bay plans shall identify and note whenever on deck 20' containers are abreast of 40' containers.
- B. Supercargo and Ship Boss shall be notified of such bays, prior to the start of the shift.
- C. Ship Boss shall notify all Foremen and all Longshore personnel working such bays.

METHOD OF DISCHARGE AND OR LOADOUT

- 1. Offset 20' containers, abreast of 40' containers, that cannot be twinned shall never have more than a two (2) tier height differential when being discharged and or loaded.
